

**ABSTRACT**

**Background:** Self-rated health (SRH) is a common measure of overall health. However, little is known about multilevel correlates of physical and mental SRH. **Methods:** Patients attending primary care clinics completed a survey before their appointment, which we linked to community data from American Community Survey and other sources ( $n=455$ ). We conducted multilevel logistic regression to assess correlates of excellent/very good versus good/fair/poor physical and mental SRH. **Results:** 43.9% of participants had excellent/very good physical SRH, and 55.2% had excellent/very good mental SRH. Physical SRH was associated with age (odds ratio[OR]=0.82 per 10 years; 95% confidence interval[CI]=0.72-0.93) and community correlates, including retail establishment density (OR=0.94, 95% CI=0.90-0.99) and percent of students eligible for free/reduced lunch (OR=1.60, 95% CI=1.08-2.38) (all  $P<0.05$ ). Mental SRH was not associated with any characteristics. **Conclusions:** Practitioners in public health, social work, and medicine could use zip codes to intervene in patients and communities to improve physical SRH.

## Area- and individual-level correlates of self-rated health:

### Implications for geographic health disparities

Self-rated health (SRH), or a person's perception of their overall health status, is a commonly-used measure in health surveys. It has been said that "self-ratings provide a simple, direct, and global way of capturing perceptions of health using criteria that are as broad and inclusive as the responding individual chooses to make them."<sup>1</sup> Single-item measures of SRH have predictive validity and test-retest reliability of overall health among respondents of different ages, genders, and ethnicity groups.<sup>2-4</sup> Importantly, SRH is predictive of many clinical outcomes; for example, people with poor SRH have a significantly higher risk of mortality than people with better SRH.<sup>1,4</sup> Most studies have focused on physical SRH, but mental SRH is a distinct and important aspect of well-being, as well.<sup>5</sup> Importantly, provision of high-quality primary care is associated with better SRH.<sup>6</sup> Thus, primary care clinicians and scientists can conceive of SRH as an *outcome* of clinical care (and other factors) and a *predictor* of clinical outcomes.

A number of individual and community characteristics impact SRH. On an individual level, older age, pain, and depression correlate with SRH. For example, older adults who are experiencing pain are more than twice as likely to report poor SRH as other older adults, even after controlling for clinical health indicators, sociodemographics, and access to medical care.<sup>7</sup> Depressive symptoms prospectively predict greater decline in SRH in older adults in the United States.<sup>8</sup> In contrast, individual-level sex is inconsistently associated with SRH.<sup>9,10</sup> In general, women report poorer SRH than men, but they have longer life expectancies; as a result, SRH has a weaker correlation with mortality for women than for men.<sup>9</sup>

3 On a community level, segregation, income inequality, and social capital all correlate  
4 with SRH. Racial residential segregation of blacks and whites is most strongly associated with  
5 poorer SRH for blacks living in high-poverty neighborhoods.<sup>11</sup> Additionally, greater income  
6 inequality has been linked to poorer SRH status.<sup>12</sup> In contrast, higher social capital is associated  
7 with better SRH.<sup>13</sup>

15 Given the importance of SRH for predicting health outcomes, we need to better  
16 understand how multilevel characteristics work together in their associations with SRH. In this  
17 study, we conducted a multilevel analysis of individual- and zip code-level variables and SRH.  
18 We examined differences in these associations for physical versus mental SRH. These findings  
19 identify community characteristics that may put patients at risk for poorer SRH, highlighting  
20 where we can locate future supportive interventions to address community factors and individual  
21 health.

## 22 23 24 25 26 27 28 29 30 31 32 33 **METHODS**

34  
35 We collected cross-sectional survey data from patients visiting seven primary care  
36 clinics<sup>14</sup> in July 2019. Patients ( $\geq 18$  years) self-administered an anonymous paper questionnaire.  
37 Of 1,769 adult patients, 464 completed a survey (response rate=26.2%), and 455 provided valid  
38 zip codes.

### 39 40 41 42 43 **Measures**

44  
45  
46  
47 **Outcome variables.** Participants reported physical and mental SRH in response to the  
48 question “In general, would you say that your [physical/mental] health is...” Responses options  
49 were excellent, very good, good, fair, or poor. We dichotomized responses into *excellent or very*  
50 *good* versus *good, fair, or poor*.<sup>15</sup>

**Predictor characteristics (Table 1).** Participants reported age, race/ethnicity, sex, marital status, and residential stability.

Community characteristics were primarily drawn from 2013-2017 American Community Survey five-year estimates and linked to participants' zip code.<sup>16</sup> These characteristics were median household income; population density; number of retail establishments per 1,000 population; average life expectancy (from 2010-2015 U.S. Small-Area Life Expectancy Estimates Project<sup>17</sup>); percent of population ( $\geq 25$  years) with at least a high school degree; percent of households whose language is only English; percent of students eligible for free and reduced lunch (from 2018-2019 [redacted] Department of Education report<sup>18</sup>); and percent of residents who are black, Hispanic, without healthcare insurance, and live in the same house as the previous year.

### Statistical analysis

We built multilevel models for physical and mental SRH, accounting for clustering of participants by zip code. For each outcome, we ran empty logistic regression models (Model 0). We calculated intraclass correlation (ICC) using the formula<sup>19</sup>:

$$ICC = \frac{\tau_{00}}{\tau_{00} + 3.29}$$

Where  $\tau_{00}$  is the Model 0 intercept and 3.29 is the level-1 error variance.<sup>19</sup> ICC summarizes the variation in the outcome attributable to level-2 (i.e., zip code) membership.<sup>19</sup>

Then, we calculated bivariate associations between individual- and zip code-level characteristics and each outcome, accounting for clustering. Finally, we constructed multivariable models simultaneously assessing the associations between individual-level

3 characteristics (Model 1); between zip code-level characteristics (Model 2); and between  
4  
5 individual- and zip code-level characteristics (Model 3) with each outcome.

8 The [redacted] determined this study was exempt from review. Analyses were conducted  
9  
10 using SAS version 9.4 (Cary, NC), with a two-sided *P*-value of 0.05.

## 13 14 15 **RESULTS**

16  
17 Participants lived in 75 zip codes (mean=6.1 participants/zip code). On average,  
18  
19 participants were 50.9 years old (standard error[*SE*]=0.9) and predominantly female (72.2%)  
20  
21 (Table 1). About half had lived in their current residence for <10 years (51.7%). On average,  
22  
23 participants lived in zip codes with a median household income of \$61,662 (*SE*=\$752.6), with  
24  
25 10.4% black residents (*SE*=0.6%) and 12.4% Hispanic residents (*SE*=0.9%).

### 28 29 **Physical SRH**

30  
31 Overall, 198 (43.9%) participants reported excellent or very good physical health. The  
32  
33 ICC for physical SRH was 8.05% ( $t=-2.05$ ,  $P=0.04$ ), indicating that zip code membership had a  
34  
35 small-to-medium effect on variation in this outcome.<sup>20</sup>  
36  
37

38 In the final, multilevel, multivariable model (Model 3), physical SRH was inversely  
39  
40 associated with age (odds ratio [OR]=0.82, 95% confidence interval [CI]=0.72-0.93), density of  
41  
42 retail establishments (OR=0.94, 95% CI=0.90-0.99), and percent of residents who were  
43  
44 uninsured (OR=0.07, 95% CI=0.02-0.35) (Table 2). Physical SRH was positively associated with  
45  
46 zip code-level average life expectancy (OR=1.47, 95% CI=1.07-2.01) and percent of students  
47  
48 eligible for free and reduced lunch (OR=1.60, 95% CI=1.08-2.38).

### 54 55 **Mental SRH**

56

1  
2  
3 Overall, 233 (55.2%) participants reported excellent or very good mental health. The ICC  
4 for mental SRH was 5.98% ( $t=2.01$ ,  $P<0.05$ ), indicating that zip code membership had a small-  
5  
6 to-medium effect on variation in this outcome.<sup>20</sup>  
7

9  
10 In the final, multilevel multivariable model (Model 3), mental SRH was not associated  
11 with any of the individual- or zip code-level characteristics (Table 2).

## 15 16 17 **DISCUSSION**

18  
19 This paper investigated the simultaneous associations of individual- and zip code-level  
20 characteristics with self-rated physical and mental health. The study was conducted with adult  
21 patients at primary care clinics in central Pennsylvania, many of whom came from relatively  
22 affluent zip codes. About half of participants reported excellent or very good physical and mental  
23 SRH. Better physical SRH was associated with individual-level characteristics (younger age) as  
24 well as zip code-level characteristics (lower density of retail establishments, higher average life  
25 expectancy, lower prevalence of uninsured population, and higher percent of students eligible for  
26 free and reduced lunch). In contrast, mental SRH was not associated with any of the individual-  
27 or zip code-level characteristics we measured in the full multivariable, multilevel model.

39

40 Physical SRH was inversely associated with individual-level age, which was expected  
41 based on previous studies. Older individuals tend to have poorer SRH than younger individuals,  
42 perhaps due to increasing prevalence of chronic and other health conditions with age.<sup>7,8</sup>  
43  
44 Interestingly, however, the link between clinical health and physical SRH weakens as people  
45 age, perhaps because social factors become increasingly influential for health among older  
46  
47  
48  
49  
50  
51 adults.<sup>21</sup>

3 Physical SRH was also found to be associated with several community characteristics:  
4 density of retail establishments, percent uninsured, and percent of students eligible for free and  
5 reduced lunch. In terms of density of retail establishments, individuals living in more  
6 commercialized communities had poorer physical SRH. Future studies should investigate how  
7 the type and mixture of retail establishments moderate this relationship; for example, living near  
8 establishments that primarily sell alcohol, tobacco, and/or unhealthy foods could hinder physical  
9 health.<sup>22</sup> In terms of percent uninsured, lack of health insurance can hinder access to preventive  
10 healthcare services, resulting in poorer long-term health outcomes.<sup>23</sup> Uninsured individuals are  
11 also more likely to have low-wage jobs,<sup>24</sup> which can negatively impact physical health through  
12 higher consumption of unhealthy foods.<sup>25</sup> Finally, in terms of percent of students eligible for free  
13 and reduced lunch, we observed an inverse association with physical SRH in bivariate models,  
14 but a positive association in multivariable models. The reasons for these associations deserve  
15 more exploration, but one hypothesis is that communities where students are eligible for free and  
16 reduced lunch could foster an environment that can reduce food insecurity and obesity rates,  
17 resulting in better physical SRH.<sup>26</sup> In summary, physical SRH is responsive to both individual-  
18 and community-level characteristics.

38  
39  
40 In contrast, mental SRH was not associated with any individual- or zip-code level  
41 characteristic in the final models. Although the ICC indicated that zip code membership helped  
42 to explain 6% of differences in mental SRH, these differences were not significantly related to  
43 the multilevel characteristics we examined. This may indicate that characteristics associated with  
44 mental SRH are subtler or more nuanced than our models accounted for (e.g., there may be non-  
45 linear associations), and/or we did not account for them in our survey. One such individual-level  
46 variable is physical activity, as physical activity can increase positive affect.<sup>27</sup> Two related  
47  
48  
49  
50

2  
3 excluded zip code-level variables are walkability<sup>28</sup> and green space,<sup>29,30</sup> both of which are  
4 associated with physical activity and SRH. Crime rate is another excluded zip code-level  
5  
6 variable, although previous studies have shown that more neighborhood crime is associated with  
7  
8 greater psychological distress,<sup>31</sup> and greater fear of crime is associated with poorer mental  
9  
10 health.<sup>32</sup> In addition, individual- and area-level degree of religiosity interact in their associations  
11  
12 with SRH,<sup>33,34</sup> so future studies could incorporate both of these variables into analyses of mental  
13  
14 SRH. Finally, the demographic makeup of our sample could also impact observed levels and  
15  
16 correlates of mental SRH, as our respondents include a majority of non-Hispanic white women.  
17  
18 Sex and racial/ethnic differences in mental SRH have been demonstrated in previous studies.<sup>35,36</sup>

20  
21  
22  
23  
24       Importantly, while various associations were found between the individual- and zip code-  
25  
26 level characteristics and SRH, we found no statistical evidence for a number of associations that  
27  
28 may have been expected, including with race/ethnicity, sex, and high school completion rate.  
29  
30 Previous studies have shown that, compared to NH whites, NH blacks have poorer SRH and  
31  
32 Hispanics have better SRH.<sup>37</sup> In the present study, our sample had low variability in racial/ethnic  
33  
34 composition, with 72.5% of participants reporting NH white race/ethnicity, which is somewhat  
35  
36 higher than the percent of NH whites in Dauphin County, Pennsylvania (64.9%); better  
37  
38 representation of different races/ethnicities may have shown a relationship with SRH.  
39  
40  
41 Additionally, the racial/ethnic compositions are aggregated data at the zip level; regression with  
42  
43 aggregated data is vulnerable to ecological fallacy, which may lead to the discrepancies between  
44  
45 results at the individual level and zip code-level. As described above, the relationship between  
46  
47 SRH and sex is unclear, with some previous studies reporting that women report poorer SRH  
48  
49 than men<sup>9,38</sup> and others reporting no difference.<sup>10</sup> The present study did not show an association  
50  
51 between gender and SRH, which again could be explained by the demographics of our sample  
52  
53  
54  
55

3 (i.e., 72.2% female). More representation from males could have provided additional power to  
4  
5 detect a sex difference in SRH. Studies have shown that individual-level education levels have  
6  
7 been positively associated with SRH<sup>13,37-39</sup>; however, our study did not show an association  
8  
9 between zip code-level high school completion rate and SRH. Had we asked participants to  
10  
11 report their own education, we may have found an association at the individual level.  
12  
13

14           These findings have implications for public health, clinical practice, and future research.  
15  
16 In terms of public health, our findings indicate that we can use zip codes to identify  
17  
18 subpopulations that are at-risk for poor physical SRH, including more commercialized areas,  
19  
20 with high percentages of uninsured and low percentages of students eligible for free and reduced  
21  
22 lunch. Interventions to improve physical SRH, perhaps by increasing physical activity and  
23  
24 reducing food insecurity, could be located in these zip codes to reach the most at-risk  
25  
26 populations. Similarly, clinical practice could use patient zip code (or zip code-level  
27  
28 characteristics) as an indicator that a person may live in a community that is at higher risk for  
29  
30 poorer physical SRH; as more attention is paid to social determinants of health in the clinical  
31  
32 setting, the environment in which patients live, and how that environment may impact health,  
33  
34 will become more important to primary care.<sup>40</sup> Future research should continue to examine in  
35  
36 greater depth the multilevel factors that are associated with SRH and other health outcomes, with  
37  
38 larger and more diverse samples. In particular, future studies could incorporate additional  
39  
40 contextual, zip code-level characteristics such as walkability, green space, and crime, as well as  
41  
42 interpersonal factors such as social cohesion and capital to create nuanced, multilevel models  
43  
44 that are ecologically valid. Importantly, identifying the individual- and zip code-level  
45  
46 characteristics that are associated with mental SRH will have important implications for  
47  
48 promoting whole-person health in primary care.<sup>41</sup> However, in all of these instances, it is  
49  
50  
51  
52

3 important to remember that SRH reflects a person's actual health status as well as their  
4  
5 idiosyncratic reporting tendencies<sup>42,43</sup>, and as such is an imperfect reflection of health, well-  
6  
7 being, and function. This construct can serve dynamically as a patient's retrospective  
8  
9 interpretation of clinical and non-clinical health issues<sup>44-46</sup> and/or a prospective marker of future  
10  
11 outcomes.<sup>47-49</sup> As a result, stakeholders from public health, clinical medicine, and research need  
12  
13 to be explicit about their hypothesized relationships between SRH and outcomes of interest.

16  
17 Strengths of our study include our respectable response rate for a survey-based study,  
18  
19 moderate variability in zip-code level characteristics ( $k=75$ ), and successful geocoding of 98% of  
20  
21 participants (455/464). However, our study does have several limitations including the majority  
22  
23 of the respondents identifying as female and white, and geographic location limited to central  
24  
25 Pennsylvania, making generalizability of our findings somewhat limited. Ecological fallacy is  
26  
27 also important to consider as a limitation; inferences made about groups based on aggregate data  
28  
29 cannot be extended to individuals.

### 32 33 **CONCLUSIONS** 34

35  
36 In this cross-sectional survey of adult primary care patients, we found that physical SRH  
37  
38 was associated with individual-level age and with zip code-level density of retail establishments,  
39  
40 percent uninsured, and percent of students eligible for free and reduced lunch. Public health and  
41  
42 clinical practice can use these results to identify and intervene with patients living in  
43  
44 communities considered at-risk for poorer physical SRH. Additional research is needed to  
45  
46 explore other zip code-level characteristics, particularly as they relate to mental SRH. This area  
47  
48 of research can support efforts to improve social determinants of health and whole-person  
49  
50 primary healthcare.
